Criteria required when applying for Ancient Mariner Membership:

A SINGLE ANCIENT MARINER MEMBER being a person who at the date of election is; over the age of seventy (70) years, has been in continuous membership of the Club for a minimum of ten (10) years and who has retired from active boating. He / she shall have one vote, except on rule changes, and is unable to be nominated or elected to the committee. He /she shall pay a reduced subscription of 50% of Full Single Membership

A COMBINED ANCIENT MARINER MEMBER at least one of the partners being; over the age of seventy (70) years, who has been in continuous membership of the Club for a minimum of ten (10) years and both partners having retired from active boating. Each partner shall have one vote, except on rule changes, and they are unable to be nominated or elected to the committee. They shall pay a reduced subscription of 50% of Full Combined Membership

TEIFI 100 CLUB (An optional monthly lottery for members as a way of contributing to club funds)
